Chair Rogers discussed the possibility of creating an outreach committee to speak at various meetings outside of the City Council. Board Member Cynthia Moran informed the Board that the Public Affairs committee is working on creating a Speakers Bureau as the outreach committee.

### WINE WALK SUBCOMMITTEE

Chair Rogers stated the sub-committee has met several times already and has incorporated a new PR member. Outreach to wineries has begun. Tickets will go on sale July 16, 2018 with "early bird" pricing. Ticket prices will increase as the event gets closer. There will be various performers stationed in several areas of Wine Walk and a Beer Garden area will be set up for the second year.

Board Member Glen Anderson reported a concert is scheduled for August. The committee is working on a play for the end of the year as well as a kid's band.
