COMMITTEE REPORTS

FUND DEVELOPMENT COMMITTEE

Chair Peter Rogers informed Board Members that tickets for Wine Walk will go on sale July 15, 2019 and there are a total of 1,050 tickets available. Board Member Sylvia Nash said there will be 3 homes decorated for the Holiday Home Tour.

STRATEGIC PLANNING COMMITTEE

Board Member Grace Capps inquired about the Trails Enhancement Project. Community Services Supervisor Melissa Armit informed the Foundation that trail maps are in production, trail mile markers have been installed for phase 2 and all items have been purchased for the last 7 trails with installation in 2020. Board Member Grace Capps encouraged committees to set 1 or 2 goals for the upcoming year and asked about future project ideas. Possible projects include funding an L.E.D. marquee, a band shell, the Military Banner program, or additional adaptive swings.

BOARD DEVELOPMENT COMMITTEE

Chair Peter Rogers informed the Foundation that there is one position on the Board that will need a replacement. He said there are a couple of candidates to consider and the candidates will be discussed once they are finalized.

CHARTS COMMITTEE

Board Member Glen Anderson reminded the Foundation that the Scotty Mac Band concert is the final concert for the 2019 Concert Series and will take place on August 24, 2019. He informed the Foundation that discussions are taking place with the Attic Theater and the Maverick Theater to add an upcoming theater component to cHARTS.

Goodman: Board Member Darryll Goodman previously attended Hot Country Nights and reported it was very well attended.

Lewis: Board Member Lewis requested authorization to look into a custom Snapchat filter for the Wine Walk.

Lee: Board Member Lee inquired about the revenue of the last Concert Series concert and asked if there should be additional security for the country concert. Senior Analyst Alma Hernandez reported the revenue of the last concert was \$2,400 plus \$1,600 in concessions. Community Services Supervisor Melissa Armit informed the Foundation that there will be plenty of staff on hand and no additional security should be required.
